Aihe: Implementation of Council Framework Decision 2008/913/JHA

Dear Sir/Madam,

During the discussion in the Council Working Party "FREMP" on the Commission's report on the implementation of Council Framework Decision 2008/913/JHA on combating certain forms and expressions of racism and xenophobia by means of criminal law (COM (2014) 27 final and its Annex SWD (2014) 27 final), the Commission informed delegations that it would engage in bilateral discussions with the Member States throughout 2014 with a view to closing gaps in the implementation of this legislation.

For this purpose we would like to ask you to indicate to us the person/s who will serve as contact point for these dialogues over the coming year.

During the discussion at FREMP, several Member States indicated that they would like to clarify certain sections of the report which may not faithfully reflect the existing legislative situation in the respective Member States.

For this reason, we would like to invite these Member States to provide the Commission with a comprehensive, reasoned analysis of these points of divergence with reference to the precise national text at issue for each point. As the Commission has already closely examined the legislation sent by Member States, we would like to invite Member States to be as detailed and schematic as possible in this exercise.

Furthermore, we invite those Member States who adopted legislation subsequent to 31 December 2013 to clearly indicate the precise changes that such new laws introduced.

In order to avoid divergences which may be caused by translation, we would also be grateful should the Member States provide us with an English or French version of all materials relevant to this exercise by 4th April 2014.

While thanking you in advance for your cooperation, we look forward to hearing from you.

This message is sent to the persons we have identified as our "natural counterparts" in the Permanent Representations. We have also added the persons who participated in our experts' group meetings. Please feel free to forward this message to the persons you consider better placed to respond to it.
