

New rules

The European chemicals legislation has changed in recent years with the introduction of four regulations that ensure the free movement of chemicals in the European Union and a high level of protection for human health and the environment:

- **REACH** - Registration, Evaluation, Authorisation and Restriction of Chemicals;
- **CLP** - Classification, Labelling and Packaging of hazardous chemicals;
- **BPR** - Biocidal Products Regulation;
- **PIC** - Prior Informed Consent in the international trade of hazardous chemicals and pesticides.

The European Chemicals Agency (ECHA) ensures the consistent implementation of these regulations across the European Union and the countries in the European Economic Area - Iceland, Lichtenstein and Norway.

We provide information in 23 official EU languages on the legislation on our website.

Terminology in your language

ECHA-term is an online service with more than 1 300 legal terms and their definitions in 23 official EU languages that can be filtered and downloaded in various formats.

You can get involved

ECHA consults the public on proposals to:

- Test substances on animals,
- Harmonise the classification of dangerous chemicals,
- Identify "substances of very high concern",
- Decide which of them will require prior authorisation,
- Authorise their temporary use by individual companies,
- Restrict certain uses of substances,
- Decide which biocidal active substances could be substituted by safer ones.
