Rights of children and young people to participate and their promotion in Finland

Closing seminar of the pilot project: Council of Europe tool for assessing progress in promoting the rights of children and young people under the age of 18 to participate

Time: 29 January 2020 at 9.00–12.30

How well does the Finnish legislation guarantee the rights of children to participate in decision-making? What kinds of structures and systems exist in Finland for ensuring the participation of children and young people? Are children themselves aware of their rights and do they think the channels for their participation are working?

In 2016, the Council of Europe introduced an assessment tool to help member states measure their progress in ensuring the participation of children and young people under the age of 18. The assessment tool was tested in Finland in 2019 in a pilot project, carried out by the Ministry of Justice in cooperation with the Ministry of Social Affairs and Health, Ministry of Education and Culture, Ministry of the Interior, Office of the Ombudsman for Children, Association of Finnish Local and Regional Authorities, Advisory Board for Ethnic Relations, Central Union for Child Welfare and Mannerheim League for Child Welfare.

The Ministry of Justice will organise a closing seminar for the pilot project. A draft report approved by the project steering group will be presented at the seminar, and further measures to advance the rights of children and young people to participate will be discussed.


