

# BOLOGNAN PROSESSI - SUOMEN TOIMEENPANOSUUNNITELMAN VALMISTELU

## *Yhteiset suuntaviivat*

- Korkeakoulutuksesta vastaavat ministerit sitoutuvat Tiranassa edistämään yhteisesti sovittujen sitoumusten toimeenpanoa vertaisoppimisella ja julkistettavilla kansallisilla toimeenpanosuunnitelmissa.
- Erityisesti huomiota kiinnitetään ns. avainsitoumusten (1. tutkintorakenteet, opintojen mitoitus ja tutkintojen viitekehykset 2. tutkintojen tunnustaminen 3. laadunvarmistusjärjestelmä) sekä sosiaalisen ulottuvuuden toimeenpanon edistämiseen.
- Toimeenpanosuunnitelma laaditaan lähivuosille siten, että saavutetuista tuloksista ja edistymisestä voidaan raportoida vuonna 2027.
- Alustava aikataulu maakohtaisille toimeenpanosuunnitelmissa on 1.3.2025. Suunnitelmaa on mahdollista täydentää tarvittaessa.
- Lähtökohtana toimeenpanosuunnitelmaalle "The European Higher Education Area in 2024 - Bologna Process Implementation Report" -julkaisun esiiin nostamat toimeenpanon heikkoudet ja tilannekuva sekä kansalliset kehittämistarpeet ja mahdollisuudet.

## *Suomen suunnitelmaan liittyviä kysymyksiä*

- Suomen osalta avainsitoumusten toimeenpanotilanne on hyvä. Ajanjaksonne osuu kuitenkin mm. korkeakoulujen visiotyö, joka mahdollistaa mm. keskustelun avaamisen tutkintorakenteisiin liittyvistä linjauksista. Miten paljon tästä keskustelua ja mahdollisia uusia suuntia tulisi ottaa huomioon Suomen toimeenpanosuunnitelmassa?
- Eurooppalaisia laadunvarmistuksen suuntaviivoja ja periaatteita (ESG) ollaan uudistamassa ja Suomen seuraavan auditointimallin suunnittelu on käynnistynyt. Miten paljon malliin voidaan tuoda uusia elementtejä, jotta osa toimeenpanon puutteista tulisi hoidettua laadunvarmistuksen kautta?
- Osa avainsitoumusten toimeenpanoa edellyttää jatkuva työtä korkeakouluissa (esim. osaamistavoitteiden kuvaus, opintojen mitoitus). Tuetaanko tästä työtä riittävästi ja tarvitaanko enemmän kansallista yhteistyötä?
- Pienten osaamiskokonaisuksien pilotointi ja mahdolliset muutokset Suomen tutkintojen ja muiden osaamiskokonaisuksien viitekehykseen.
- Mitä muuta pitäisi tehdä toimeenpanon edistämiseksi ja nostaa Suomen toimeenpanosuunnitelmaan?

### General information

#### *Introduction and scope of the national action plans*

With the Paris Communiqué, "a structured peer support approach based on solidarity, cooperation and mutual learning" was adopted. In the work programme of the European Higher Education Area (EHEA) for 2018-2020, peer support focussing on completing the implementation of three key commitments was included through thematic peer groups (TPG). As a follow-up of the Tirana Communiqué, an additional TPG on the social dimension of higher education was added, in order to address and ensure the implementation of the principles and guidelines for the social dimension as adopted in the Rome Ministerial Conference.

In order to ensure a cohesive and consistent approach to a strategic and well-thought through action plan for the implementation of the key commitments, as well as other commitments of

the Bologna Process, countries are asked to prepare a national action plan for the implementation of the Bologna Process commitments in the current working period 2024-2027.

National action plans must address the implementation of the key commitments, and additionally should consider other Bologna commitments, as agreed to within Ministerial Communiqués, which need to be further implemented by the member state concerned (social dimension, fundamental values, learning and teaching including student-centred learning, internationalisation and mobility, digitalisation etc), as well as knowledge sharing activities

#### *How to fill in the action plans and their use for the 2024-2027 working period*

The national action plans should cover topics related to the implementation of the key commitments, of the social dimension of higher education as well as other reforms that are planned in the national context for (better or more complete) implementation of the Bologna process commitments. In particular, countries are encouraged to include topics that have been identified as not entirely implemented in the [Bologna Process Implementation Report 2024](#).

The national action plans can and should be prepared involving relevant stakeholders, bodies, and institutions in the national context, such as QA agencies, ENIC-NARIC offices, internationalisation and mobility offices, national students' union(s), national rectors' conferences, and the like, as appropriate and relevant for each topic. The BFUG representatives of each country should ensure that the submitted template is coherent and that the summary points provided at the start of the country action plan cover the key topics clearly and comprehensively.

The BFUG members may update and supplement their national action plans as necessary by submitting an updated version to the BICG.

#### *Monitoring/outcomes*

The country action plans sections for the four topics covered by the four TPG will feed into each TPG work plan for the period, and their achievement will be monitored – and supported – within the framework of the TPGs.

Each country should create a structured mechanism for monitoring and evaluating the implementation of the national action plan, according to their national context. The mechanism should engage the stakeholders consulted for the creation of the national action plan.
